12. COMPETITION RULES AND SEEDING

RECOGNIZED POOMSAE AND FREESTYLE

Last updated WT Poomsae Competition Rules & Interpretation (September 30, 2024) shall be applied. For seeding the latest rules and regulations of the WT Poomsae Ranking Bylaw (September 30, 2024) are applicable.

PARA POOMSAE:

The latest updated World Para Taekwondo Poomsae Competition Rules (September 30, 2024) will be implemented for competition in the Poomsae Sport Classes. Article 9.1 will be used for competition for *P20 Sport Classes*, there is a free choice to athletes to choose any recognized Poomsae and other sport classes can choose (1) Poomsae from Group 1 and (1) Poomsae from Group 2 for each round.

13. HEAD OF TEAM MEETING

14. CONTEST TIME

- Recognized Poomsae: individual, pair, and team competitions up to 90 seconds. The waiting period time between the 1st poomsae and 2nd poomsae is 30 seconds minimum.
- Free Style Poomsae: individual, pair, and mixed team competitions from 90 seconds to 100 seconds.
- Para Poomsae: individual competitions up to 120 seconds. The waiting period time between 1st poomsae and 2nd poomsae is 60 seconds minimum.
- The WT Technical delegate has the authority to adjust the contest time as he sees fit.

15. COMPETITION SYSTEM

RECOGNIZED POOMSAE:

- Single Elimination Tournament System: competition shall be conducted in a single elimination tournament. Designated Poomsae shall be randomly selected and shown through monitor on Field of Play before the match begins.
- Individual Categories: Contestants shall perform two (2) randomly selected Poomsae. Both Chung and Hong players perform their assigned Poomsae simultaneously (side by side).
- Pair and Team Categories: Contestants shall perform two (2) randomly selected Poomsae. Chung and Hong players perform designated Poomsae one by one (not side by side).
- Before each match starts, two (2) designated Compulsory Poomsae will be displayed on the monitor at the Field of Play. All divisions must perform these for the preliminary, semi-final, and final rounds in all competitions.
- Ending Position: The new WT rules and regulations stipulate that there are no deductions in Poomsae performance for ending positions that differ from the starting position.

FREESTYLE POOMSAE:

- All Freestyle medal events: final round (only 1 round), independent of number of athletes
- Cut-off system: The organization can change this due to organizational matters.

PARA POOMSAE:

• Single elimination tournament system











16. FREESTYLE POOMSAE

GENERAL INFORMATION FOR ALL CATEGORIES:

- All Acrobatic techniques must incorporate Taekwondo kicks.
- It is allowed to include max. 3 acrobatic combinations during the whole performance (Note: this is new, after World Poomsae championships in Hong Kong)
- Every extra acrobatic technique or combination will lead to a deduction of 0.3 points from the total score.
- An acrobatic combination can be a single acrobatic action (such as Salto forwards, backwards or sideways) or combination of consecutive single acrobatic actions. Each of them will be considered as one acrobatic combination.
- Each simultaneous acrobatic performance of team/pair members will be considered as one acrobatic action/combination!
- If each member of the team or pair performs their acrobatics after the others (not simultaneously), it will not be considered as a single acrobatic combination/action.
- Consecutive sparring kicks (7 − 10 kicks)
- Minimum number of consecutive sparing Kicks (7 Kicks) should be performed by the same athlete in one direction. It is not allowed to change direction more than 90 degrees.
- It is not scored for turnaround (change direction by 180 degrees)
- It is not allowed to perform 1-1 sparring (face to face).
- Punches are not counted for "minimum 7 consecutive sparing kicks"
- Double kicks are only counted as 1 kick.
- Triple and more are counted as 2 kicks.
- It is mandatory to bounce min. 3 to max. 5 times in place (clearly) before execution of consecutive sparring kicks. This means that, if the competitors who forget to bounce, execution of the consecutive sparring kicks is not scored!
- Mixed Team Divisions Board Breaking

Board breakings in the following three technical skills are required:

- Gradients of spins in a spin kick
 Kyorugi style consecutive kicks
 Acrobatic kicking technique
 (1 to 3 boards) minimum 1 board
 (3 to 7 boards) minimum 3 boards
 (1 to 3 boards) minimum 1 board
- Minimum number of boards breaking during a Performance: 5 (1+3+1) boards.
- Each compulsory foot technique is awarded a maximum of 0.7 (basic score) if the required minimum number of board breaking is not successfully performed.
- 0.1 points are deducted for each unsuccessful board breaking.

Board Breaking: The **pine board** has the following measurements:

Length 300 mm Width 220 mm

Thickness 9 mm (ca. 1/4 inch)

Notice: The required number of boards that fit the given dimensions must be brought by the mixed teams (participants) on their own (5 to 9 boards).











- Board holding sticks prepared by teams are allowed for only the acrobatic board breaking technique.
- Gradients of spins in a spin kick (Jump Turn Kick): Only piggybacking allowed. Piggyback refers to the action of sitting on a teammate's shoulders (not standing) in order to hold a board.
- Acrobatic kicking technique (Acrobatic Kick): Both support/boosting and piggyback are allowed. Support/Boosting means assisting a teammate's jump.
- Holder of the board breaking can only be within the 5 members of the mixed team. Any of the five performing members (not substitute) can execute board breakings.

The required boards are placed inside the court (within the boundary line);
Otherwise, 0.3 points will be deducted for each crossing of the boundary line to get the board.

• Mandatory Stances:

- Hakdari Seogi, Beomseogi, and Dwitgubi
- All stances must be performed clearly and accurately. For pair and mixed teams, athletes must perform the stances at the same time.

Music freestyle:

- athletes must bring their music (sound without lyrics/words) in MP3 format on USB-stick. Apple audio format is <u>not</u> allowed. The music and choreography shall be the choice of the contestant. It should <u>not</u> contain any political, social and religious or any contents that may harm, discriminate or offend others.
- Music should be submitted on USB stick at the Head of team Meeting with the following details:
 - Name of the country
 - Name of the category
 - Name of the athlete/athletes

17. GENERAL ELIGIBILITY REQUIREMENTS

- Contestants may compete in a maximum of two (2) medal events
- Recognized Poomsae and/or Freestyle Poomsae competition unless he or she is limited by gender or age. Example: Recognized Poomsae max 2, or Freestyle Poomsae max 2, or 1 each of categories
- Holder of a valid 2025 WT Global Athlete License
- A participant must be a member of a pertinent Member National Association, recognized by the Europe Taekwondo Union or World Taekwondo (only National Teams)
- Para: a participant must be a member of a pertinent Member National Association, recognized by Europe Taekwondo Union or World Taekwondo. (Open for National Teams only with max. 2 athletes per medal event per national team)
- Holder of the nationality of the participant team.
- European Poomsae: 1st Dan/Poom, and above-WT regulations
- European Para Poomsae: holder of a Para Taekwondo Dan issued or recognized by WT or an 8th – 1st Geup certificate issued or recognized by WT.











18. AGE ELIGIBILITY

- European Championships Poomsae: born 2013 or before
- European Championships Para Poomsae: born 2009 or before
- The age limits for each division are based on the year, not the birthday date
- All competitors must prove their age by presenting their passport or identification card.
- For those athletes that are not adults, a written consent must be submitted (please find enclosed on the last pages) at the registration, signed by one of the parents or legal guardians, accepting their participation and all parts of the official invitation.

19. COACH ELIGIBILITY REQUIREMENTS

- Minimum age of 18 years
- Holder of a valid 2025 WT Global Official License
- Coaching is not allowed wearing Dobok & sandal
- Poomsae WT coach certification
- Para WT coach certification

28. PROOF OF PAYMENT REQUIREMENT

All teams are required to send proof of payment (copy of bank transfer) to finance@europetaekwondo.org within (1) week after registration in Simply Compete.

29. NO REFUND POLICY

European Taekwondo Union/ Organizing Committee does not refund entry fees paid.

30. PROTEST FEE

200 euro which is non-refundable. Each team is responsible for submitting the protest in the proper manner and according to the applicable rules and regulations.

31. REPLACEMENT

Replacement of athletes, pairs or teams after the registration deadline is only possible until <u>13 April</u> 2025, 23:59 CET. The following rules are applicable:

- Replacement can be done only if all entry fees and accommodation obligation fees have been paid in full
- A fee of 150 euro is applicable.

32. ACCREDITATION FEES

25 euro for replacement and reprinting request per accreditation card

50 euro for each additional coach accreditation

50 euro for each on-site <u>approved</u> additional requested accreditation card or on the top of the accreditation cards quotas.

33. IMPORTANT NOTES:

- European Taekwondo Union/Organizing Committee has the right to delete sport entries from teams that do not send proof of payment from the system in order for other athletes to register and to prevent 'ghost athletes'.
- Any athlete registering on-line who does not take part in the competition and who has not been removed from the entry list before **06 April 2025**, is liable for paying his/her entry-fee in full. For any athlete not presenting at registration, his/her team or official will be liable for ensuring full payment has been received, prior to the team's participation.
- If a team does not show up at the event and has not requested a participation cancellation before the deadline, the federation will be invoiced to settle the payment of the entry fees in full (100%).












34. ACCREDITATION CARD DISTRIBUTION

For all registered athletes, the entry fee must be paid before the accreditation cards will be distributed to the respective team.

Registered teams will receive all accreditation cards (athletes, coaches etc) if all financial obligations (including hotel fees) have been fulfilled.

35. SPORT EQUIPMENT

Dobok: participating contestants must wear the WT-recognized Poomsae Competition uniform. Any contestants who do not wear WT-approved Poomsae competition uniform will not be permitted to compete. 


37. PARA POOMSAE SPORT CLASSES & ELIGIBILITY

For the P20 Sport Class, Virtus International Eligibility is still recognized. WT will conduct its own sport specific classification for P20 sport classes. There will be a Medical Diagnostic Form (MDF) for P20. An IQ test from a verified psychologist will be required as well as a medical report. If Atlanto-Axial Instability (AAI) is present with downs syndrome this needs to be noted too. MDF and IQ test, AAI is required to be uploaded to the WTCS.















































































38. MEDICAL DIAGNOSTIC FORM (MDF) for K40, P20, P30, P50 & P70

- The Medical Diagnostic Form (MDF) is to be completed in English by the athlete's individual physician or physio therapist.
- The completed form must be submitted on 11 March, 2025 before the athlete undergoes athlete evaluation. This applies to all athletes with physical impairment competing in WT. Depending on the athlete's health condition and impairment, additional medical information is to be attached to this form (see page 2). Please consult the WT Classification rules for a list of eligible impairments and underlying health conditions for Kyorugi and Poomsae.
- There will be separate MDFs for P20, P30, P50, P70
- For the P20 Sport Classes a new system for eligibility will be introduced. There will be an "MDF" for P20. An IQ test from a verified psychologist will be required as well as a medical report. If AAI is present with downs syndrome this needs to be noted too.

- NOTE: Failure to submit MDF and medical information can lead to your athlete not being able to be classified and receiving a "Classification Not Complete", "CNC". The athlete will then not be able to compete at the event.

42. MEDICAL AND ANTI-DOPING

- Applicable medical rules: the WT Medical Code is applicable, which all MNA participating this event must comply.
- Applicable doping rules: the WT Anti-Doping Rules and the WADA Anti-Doping Code are applicable. Compulsory random doping tests will be conducted among all athletes. World Taekwondo and/or WADA may carry out random out-of-competition testing prior to the event.
- Therapeutic Use Exemption: athletes who take any substance or medicine listed in the "Prohibited List" of the WT Anti-Doping Rules and WADA Anti-Doping Code for therapeutic purposes are requested to submit TUE applications via ADAMS, together with the required medical information.
- Otherwise, please download the TUE Application Form (found on https://ita.sport/TUE), and once duly completed and signed, send it together with the required medical file to tue@ita.sport. Report TUE applications also to the WT Sport Department via antidoping@worldtaekwondo.org by no later than 4 February 2025.

44. HOTEL ACCOMMODATION

All athletes participating at the 17th European Poomsae Championships & 2nd European Para Poomsae Championships 2025 shall mandatorily book their hotel accommodation via the Organizing Committee for the duration of their stay. Any member of the team that does not comply with this regulation shall pay a fee of 100 euro to the OC.
